POLISH LICENSE & PREP COURSES

Students who study the first three years at AMA MEDICAL CAMPUS (option to choose BSMU or KSU) in Ukraine at the Polish border facilities and the last three summer break, with no additional fees. Students at the AMA Medical Campus near the Polish border (in Ukraine) also have the opportunity to participate in a 2to 4-week study tour program, accompanied by a faculty member, to visit EU teaching hospitals. Each candidate can participate up to three times during their six years of study, with no additional tuition or training fees.



Degrees obtained from KSU and BSMU are accepted by Poland, Croatia, Canada, the U.S.A., India, Australia, the EU, the UK, and worldwide.
